- Brewton Parker College receives all Stafford and PLUS loan funds by electronic funds transfer (EFT) that will be credited directly to the student's account.
- Notification of all loan funds credited to the student's account will be mailed to your permanent address. If you wish to cancel all or a portion of your loan, the written request must be received in the Financial Aid Office within 14 days of the date of your EFT letter.
